Colorado's Healthcare Landscape

- Colorado ranks 8th in U.S. News Top Ten Healthiest States, with low rates of adult obesity and mortality rates
- Nationally recognized for promoting the health and wellbeing of its residents


- Colorado is a highly collaborative state



- Because of this broad collaborative involvement, Roadmap truly represents Colorado




Roadmap aligns with national initiatives - HIMSS 2017 Congressional Asks, cybersecurity, health IT governance, telehealth, and broadband
